OFFICIAL RULES

NO PURCHASE NECESSARY

SWEEPSTAKES DESCRIPTION: The Jul/Aug 2026 CSA Sweepstakes (the “**Sweepstakes**”) begins on July 1, 2026, at 12:00:01 a.m. Eastern Time (“**ET**”) and ends on August 31, 2026, at 11:59 p.m. ET (the “**Sweepstakes Period**”). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Scope Zero, 300 W 57th St, Floor 33, New York City, NY 10019 (“**Sponsor**”), which shall be final and binding in all respects. Participation is also subject to the CSA Program Terms and Conditions available at <https://app.scope-zero.com/terms/> the “**Terms**”). In case of a conflict between the Terms and these Official Rules, as it pertains to the Sweepstakes, these Official Rules shall govern.

ELIGIBILITY: Open only to legal U.S. residents residing in the fifty (50) United States and the District of Columbia who are 18 years of age, have not already won a prize from Sponsor in any sweepstakes or other promotion during the current calendar year, and are registered participants of a CSA program (the “**Program**”). The Program is free to join. Go to <https://scope-zero.com/> for more details. Employees, officers, and directors of Sponsor, its parent, subsidiaries, affiliates, sales representatives, prize providers, advertising and promotion agencies (collectively, the “**Sweepstakes Entities**”), and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Sweepstakes or win a prize. Sweepstakes is void where prohibited by law.

HOW TO ENTER: During the Sweepstakes Period, you may redeem one (1) Program points in exchange for one (1) entry into the Sweepstakes. To enter using Program Points, go to the log-in corresponding to your Program membership (the “**Website**”), log in to your Program account, and follow the instructions to redeem points. The Website’s database clock will be the official timekeeper for online entries in this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor’s satisfaction, the affected entry will be deemed ineligible. The Sweepstakes Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes.

The Sweepstakes Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. **Limit two thousand (2,000) entries per person and/or per e-mail address during the Sweepstakes Period regardless of method of entry.**

WINNER SELECTION AND NOTIFICATION: At the conclusion of the Sweepstakes Period, one (1) potential prize winner(s) will be randomly selected from all eligible entries received during the Sweepstakes Period. The potential prize winner(s) will be notified by mail and/or e-mail, using contact information associated with their Program account. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond as directed by Sponsor within five (5) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if they have not complied with these Official Rules or decline the prize for any reason prior to award, such potential prize winner will be disqualified and an alternate potential prize winner may be selected. **The odds of winning depend on the number of eligible entries received.**

PRIZE(S)/APPROXIMATE RETAIL VALUE(S): One (1) Prize is available. The Prize consists of the opportunity for the winner to select up to \$150.00 in water-saving devices for their home. Winner and Sponsor will work together to determine the exact devices that will be appropriate for their situation. The approximate retail value (“ARV”) of the Prize is \$150.00 USD.

GENERAL PRIZE CONDITIONS: No cash alternative or prize substitutions will be allowed, except Sponsor reserves the right to substitute prize(s) of comparable value if a prize listed is unavailable for any reason. Prize winner(s) shall be solely responsible for all federal, state and/or local taxes, and the reporting consequences thereof, and for any other fees or costs associated with the applicable prize. Any potential prize winner will be required to execute an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, “**Prize Claim Documents**”). If winner fails or refuses to sign and return all Prize Claim Documents within five (5) days of prize notification (or a shorter time if required by exigencies), winner may be disqualified and an alternate winner may be selected. Should any individual collectively win prizes valued at \$2,000 or more in 2026, such winnings will be reported to the IRS and a 1099 will be issued to the winner.

Sponsor makes no warranties, and hereby disclaims any and all warranties, express or implied, concerning any prize furnished by third parties in connection with the Sweepstakes. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
